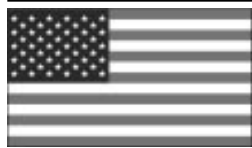

PINE RIVER -- Heather Gilmer, a former driver for *Response Delivery, Inc.* ("Response") (also a subcontractor for *DHL* courier service), said that it is not uncommon for their deliverymen to have to drive for 13 hours straight, or more, without time for rest or breaks, or face termination. Responses's Brainerd office is operated by Keith Laorange, who also operates *DHL* in areas north of the Twin Cities, in the Dakotas, and per Mrs. Gilmer, possibly in Wisconsin.

So it was on July 5th and 6th, 2005, as her husband, Eric Gilmer, also a driver for Response, had to work a 17-hour day, and then take out another route, with only about 4 hours for sleep in between.

Gilmer died in an accident at approx. 10:30 a.m., July 6th, when, deprived of sleep by the work demands, he fell asleep at the wheel of his Response van. As reconstructed by Mrs. Gilmer from photos and recounts of the accident, the van went off the road, hit an embankment and "went end over", crushing the driver and passenger area. A photo of the vehicle disclosed the flattened and crushed roof and windshield area.

**Events leading to the tragedy.** On July 5th, 2005, the day before the fatal wreck, both Heather, and Eric Gilmer, were employed by Response Delivery Inc. as route drivers. Heather had the day off, but because another driver had made, as Heather puts it, "a gross error", Heather was called in to work, that evening, by Response manager Brad Benzick. She was to finish the other driver's route, and then drive a delivery to Clearwater, Minn., about 70 miles S. of Brainerd.

Heather's route was normally in the Bemidji area; she didn't know the region to which she was

dispatched, but her husband, Eric, had worked that region for Response and was familiar with it; so Response authorized Eric, after he had finished his normal route, to accompany Heather on the route she had been called in for and assigned that evening. They would deliver to Clearwater in the Response van, then Eric got their personal vehicle at the Response location in Brainerd, and returned to their home in Pine River; Heather had additional deliveries to make between Brainerd and Pine River.

Per Heather, neither of them got home before 11 p.m. They retired, but, "He [Eric] . . . kept looking at the clock all night 'cause he knew he had to be up in just 4 hours" to take his morning Response route, Mrs. Gilmer said.

"He didn't get any sleep, and he was . . . expected . . . to be in Brainerd at 5:30 (a.m.) . . . It's a 40-45 minute drive from . . . [Pine River to Brainerd]," she said.

Heather Gilmer explained that, that morning, her husband called her several times from the road, on his cell phone, telling her that he was "very sleepy". She told him to pull over and take a nap, but Eric replied that he couldn't, because another driver in the relayed delivery had arrived late, causing Eric's van to be loaded late, and that load, pharmaceuticals, had to all be delivered by noon. "The autopsy didn't even show caffeine in his system, ergo he didn't even have a chance to even pull over and get some coffee or anything," she said.

"So he was calling me . . . that he was falling asleep at the wheel; and then the calls stopped," said Heather.

Although Response knew of the accident shortly after it happened, Heather, on a route of

her own, wasn't told. "For the rest of that day I had been trying, to no avail, to get a hold of my husband," Heather said, adding that she called Response, "and they told me that, no, he had not gotten back yet, and that they didn't know what was going on."

Heather recounted that she hadn't gotten much more sleep than Eric. "I woke up when he did," she said, adding that she was also falling asleep at the wheel that day on her route.

Heather said, "There were no 'sub' drivers . . . If he'd have called in and said 'I'm too tired to drive,' they [Response] would have fired him."

She continued, "When I called . . . [Response] . . . asking about my husband, they already knew he was dead. [Later] I got to the Westridge office [of] Wells Fargo [Wells Fargo Bank, Bemidji - one of Heather's delivery stops] . . . at 3 o'clock." Heather recounts that the branch manager brought her into a room where she found Response dispatcher Brad Benzick and some police officers. It was then that she was informed of her husband's death about four hours earlier.

Another driver took the rest of Heather's route (she would normally have driven from 7 that morning to after 7 that night), and she was taken home to Pine River.

**Religious violations.** Heather Gilmer and her husband, Eric, were of the Jewish faith; Eric by conversion. Heather was concerned because Eric's body (Cont'd, "Death by Driving," p. 3)

## Update: The Bemidji Police Chief Preece Swindle Trials

MINNEAPOLIS -- In regard to the bankruptcy of Bemidji Police Chief James "Bruce" Preece, amidst adverse claims of fraud and swindle, the Court has scheduled a *status conference* on two of these claims before the United States Bankruptcy Court at Minneapolis, Courtroom 7 West (7th floor), on March 8, 2006 at 11:30 am, before the Honourable Judge Nancy C. Dreher (Case nos. 03-44978; ADV 03-4265; ADV 03-4285).

The status conference is in connection with two adverse claims to Preece's bankruptcy, totalling over \$556,000, due to Preece's allegedly fraudulent dealings in helicopters, while his firm, *Helicopter Flight, Inc. (HFI)*, was located at the airport at Crystal, Minnesota. Generally, debts arising by fraud may be excluded from discharge in bankruptcy. The fraudulent dealings included taking and retaining sales proceeds for helicopters which could not be lawfully delivered to the customers, and delivering of a false FAA Bill of Sale for a helicopter that neither Preece, nor HFI, owned.

**Parties.** Plaintiffs in the two adverse claims include Ken Schoenfelder, Rochester, Minn. and his aviation firm of Blue Skies, Inc., represented by Michael S. Dietz, Esq., of Rochester; and Central Boiler, Inc. (operated by Dennis Brazier), Greenbush, Minn., represented by Edward F. Klinger, Esq., of Moorhead, Minn. Preece is represented by Thomas Miller, Esq., Wayzata, Minn.

HFI was formerly a *Robinson Helicopter* dealer, and Preece is alleged, in several separate incidents, to have accepted payments in full for Robinson helicopters, which payments were not turned over to the manufacturer (Robinson), causing some customers to have to pay for their approx. \$300,000 helicopters twice in order to take delivery.

Shortly following the first reports of these frauds surfacing in 2002, Robinson cancelled HFI's dealership. It is estimated that Preece's total helicopter swindles (see previous reports, post) exceed \$1 million in the aggregate, including sales to the customers who have made claims, and others.

**Preece remains the Chief of Police for the city of Bemidji, Minnesota; no criminal action for the massive and repetitive frauds has been brought against him by prosecutors.**

As of early February, there had been no dispositive action on another adverse claim, this one made by the bankruptcy trustee and relating to an allegedly improper payment, outside of the bankruptcy, by Preece, of \$52,000 to his mother's (Norma Preece's) loan account at First National Bank of Deerwood (formerly Northland Community Bank); and the matter is reported to be approaching possible settlement. The trial previously scheduled for Feb. 3rd, 2006, was cancelled and stricken.

An additional objection to Preece's Chapter 13 bankruptcy plan was filed in Sept. 2005 by the Special Asst. Attorney General for the State of North Dakota, on behalf of the North Dakota Tax Commissioner. The objection seeks payment of North Dakota withholding taxes, interest and penalty totalling \$674.50. Preece's original chapter 7 bankruptcy petition disclosed a \$90,000 federal tax lien and listed, as a priority debt, \$41,615.12 as payroll taxes, owed to the Internal Revenue Service.

**"Crisis Line" Can Create One**

LAKE GEORGE -- John Defatte was despondent over the then-recent death of his son. He needed someone to talk to. But the last thing he needed was a team of deputies coming to his home, macing him, and incarcerating him for two days of "observation."

As Defatte recounts it, on Friday, Sept. 3rd, 2004, at 5:54 p.m., "I called a crisis line," in Bemidji, and he was transferred to a crisis nurse in Thief River Falls. Defatte told her what was bothering him, but at no time indicated that he was in any way suicidal. In interview, he continued, "We talked for about an hour, I did feel a lot better; and she asked me straight out, 'Are you planning . . . to kill yourself,' I said No!"

Defatte didn't give her his name, but supplied enough identifying information in the conversation that deputies were able to pinpoint who he was when, after the conversation with Defatte, the Thief River Falls crisis nurse called them, described Defatte as "acutely suicidal" (per official transcripts of the calls) and related the supposedly confidential crisis call to them.

The next thing Defatte knew, Hubbard County deputies, under the direction of the office of Sheriff Gary Mills, sent what appeared to Defatte to be a SWAT team, to

**FBI Alerts Public to E-Mail Scam**

WASHINGTON, D.C. - The FBI is warning the public of a fraudulent e-mail in circulation that requests financial assistance for the survivor of the tragic mining incident in Sago, West Virginia. The e-mail falsely claims to be authored by a physician at the hospital where the survivor received medical attention. It describes the condition of the survivor and the financial assistance that is needed for a full recovery.

The FBI takes these matters seriously and is working with other law enforcement and private industry partners to identify the person(s) responsible. Anyone who has received an e-mail of this nature is asked to contact the FBI's Internet Crime Complaint Center (IC3) via the website at http://www.ic3.gov

As was learned after the tragic events of 9/11/01, the Tsunami disaster, and more recently with Hurricane Katrina, unscrupulous cyber criminals have shown the desire and means to exploit human emotion by attempting to defraud the public when they are perceived to be most vulnerable. Computer users are strongly urged not to open or respond to unsolicited e-mails of any kind. Furthermore, e-mails requesting personal information or soliciting funds should be thoroughly verified for their legitimacy before responding.

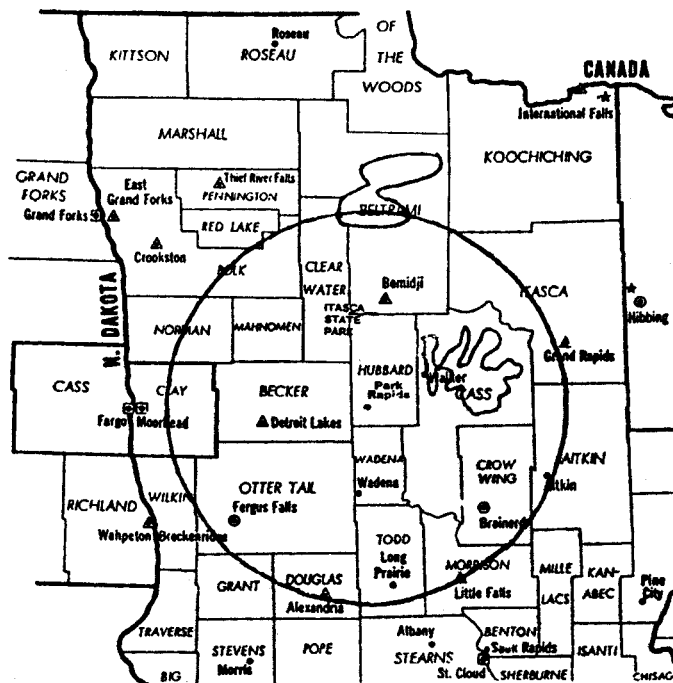

were three cops on me . . . they threw me to the ground, and this other cop that had maced me, maced me again, under my glasses . . . when I was on the ground."

The deputies transported Defatte, in handcuffs, to the Hubbard Co. Sheriff's office. "They pushed me back up against the wall - I had a cut on my forehead from it," he said. The deputies removed the handcuffs, put Defatte in restraints and transported him first to the Park Rapids hospital, and then to the mental facility at Brainerd.

"He claimed I was suicidal and I wasn't," Defatte maintains.

"They threw me into a padded

cell," said Defatte.

Defatte's wife was at work when he was arrested, and had no knowledge of the incident. She came home to find her husband gone, and called the Hubbard Co. Sheriff's Dept. trying to find out where he was, but deputies refused to tell her of the arrest, "They didn't know anything," said Defatte, so Mrs. Defatte spent a good part of the weekend not knowing her husband's whereabouts or condition. Defatte, being held on a 72-hour watch, was not allowed to telephone her, or anyone else.

On Sunday morning, Defatte was finally seen by a physician, who, after speaking with him for about 5 minutes, as Defatte related, told him, "You don't even belong here. . . . What we have is some

deputies that overreacted." The physician called Mrs. Defatte who then had to drive from their home at Lake George, to Brainerd, to pick Mr. Defatte up at the hospital.

"I will never, ever, call . . . [a crisis line] . . . for help . . . again," said Defatte.

Afterward, Defatte attempted to speak to Hubbard Co. Sheriff Gary Mills about the actions of his deputies, but "Sheriff Mills never answered any of my phone calls," and did not return Defatte's calls requesting an appointment to see him.

Defatte indicated that he is presently working with an attorney to bring suit against Hubbard County for the false arrest.

Hopefully, it will be for a few billion \$\$s -- Ed.

**Charges Urged Against Park Rapids City Attorney John Masog for Check Kickbacks**

PARK RAPIDS -- Following an FBI investigation of John Masog's having, allegedly, improperly received over \$38,000 in bad check fees, which would otherwise have gone to the merchant-victims of the bad checks, Mahnomen Co. Attorney

Julie Bruggeman (to whom the case was referred due to obvious conflict of interest by the Hubbard County Attorney) has drafted a criminal complaint against Masog for felony theft, but, due to familiarities, she can't find an officer to sign it; as reported the

(Minneapolis) Star-Tribune. And Park Rapids Mayor Ted Godfrey wants Masog brought to justice.

had, without her consent, been transported to St. Paul for autopsy, something not allowed by orthodox Judaism, which also requires that the body be buried within 72 hours.

"They had already shipped him off to get him autopsied . . . I did not have a choice in the matter," she said, adding, "I wasn't even allowed to see my husband until well after 72 hours after he was killed." And due to Heather's inability to procure a proper Jewish burial, and also to

there being no Jewish mortuary nearby, the body had to be cremated, which also violates Jewish law. Heather reports that she, nonetheless received excellent service from a local funeral home at Pine River. "Jay Kline was fantastic," she said, "he was very helpful."

Response Delivery, Inc., however, was far less helpful after the fatal accident that, Heather maintains, their work policies caused. In the end, Response would deny liability for the wrongful death, fire Heather, deny her worker's comp rehabilitation benefits, and only pay her worker's comp death benefits of \$35.41 a week to replace Eric's salary - far less than the approx. \$220 per week to which she is entitled.

# Is Our Road Salt Rusting Crawfish, Too?

Why reinvent the wheel? I am fed up with the fishing on Leech Lake.

Woman Lake was in bad shape 6 or 7 years ago. Now the Walleyes are on the come back. Because of people like Tom Held, Gene Carlson, Dan Krone, Fritz Felton, Ron Felton, and myself, along with others. With people like I mentioned you keep the rusty crawfish limited, and with the Minnesota DNR stocking, the Walleyes will come back.

The rusty crawfish came from the Ohio Basin. By fishermen in the 40s and the 50s [using them] as bait. The rusty crawfish left over were dumped into lakes. That is how they got their start.

The rusty crawfish have multiplied fast over the years. How many more have multiplied in Minnesota lakes? One crawfish will have 500 or more offspring in mid-June. Then the rusty crawfish will molt, and become soft shell and within 3 hours they become hard shell again. The rusty crawfish has destroyed weed beds, wild rice, and has eaten eggs of every kind of in the lakes. They are like underwater loggers on the bottom of the lakes. Destroying everything in their paths. Now the Minnesota DNR wants to study the rusty crawfish.

I don't know why they can't look at Sparkling Lake in Wisconsin or what Wisconsin DNR has already done. (Ref.: The studies on the rusty crawfish - *The role of predators in the Sparkling Lake rusty crawfish and rainbow smelt removal* - <http://limnology.wisc.edu/roth/The%20role%20of%20predators.htm>).

Do we have the time to study what has already been studied? We don't have a good population of Walleyes in Leech Lake now. Can we throw another 12 to 15

years of fishing away? When the study will take 5 to 6 years? That is how long it will take the Walleyes to come back. 12 to 15 years! At Sparking Lake, Wisconsin DNR did a intensive harvest and kept up trapping the rusty crawfish. Low and behold the walleyes have come back!

The Minnesota DNR should put a bounty on the rusty crawfish. Like they have with problem beaver. Why give a college a big lump of money when Wisconsin DNR has already studied the rusty crawfish? Give half the money you would spend to the college for the study and the other half to set up bounty on the rusty crawfish. Like 40 to 50 cents a pound to the crawfish trappers. That seems more reasonable then doing what Minnesota DNR wants to do. Let's review the facts Wisconsin DNR has ... [developed at] ... Sparkling Lake.

Besides it would create more jobs in Northern Minnesota which would help out Minnesota DNR, ... and the State economy.

The Minnesota DNR told people at a meeting held in Walker that the rusty crawfish go dormant during the winter months. That is wrong. I went out to Leech Lake and set a trap through the ice on January 28, 2006; and on January 29, 2006, I pulled the trap. What did I see? Crawfish! Then the Minnesota DNR told me the crawfish metabolism slows down. Even if it does, they still have to eat!

In the meantime, I had gotten a hold of some perch eggs, minnows, and rusty crawfish, [and] put them together in a tank. The crawfish started to eat the perch eggs within a minute. So there are a couple studies that didn't cost the State a couple of million dollars. I don't see why the Minnesota DNR has to waste money on the studies that Wisconsin DNR has already done. Why can't they have a meeting with the crawfish

## Minnesota Woman Must Abandon Home If No Funds For Fuel Fuel Assistance Didn't Adjust For Current Costs

I am a disabled woman aged fifty six, and have lived on Social Security for fifteen years. I have managed to maintain my small home and an old pickup truck for transportation. My home has no running water, no workable plumbing. I live three miles from a small town in an old house trailer. Its not much but I am happy here.

Because of neglect on the part of my government, my home I have lived in for twelve years is now in jeopardy. If I cannot find funds to heat my house trailer I will have to move into the local nursing home. Or a woman's shelter.

I feel that our Federal Fuel Assistance Program has betrayed me and other people like me with neglect. No provision was made in the fuel assistance program for the rapid raise in propane and fuel oil prices. Living 200% below the poverty limits in this country seems like reaching for a sky hook. It's never there, always out of reach. I scrape by every month with never enough to eat. I make a lot of my own clothes. I have no pets, gave away my dog when gasoline prices got high.

Last month I was very short on food. I had to give up 1/4 of my food budget for a fuel delivery that fuel assistance would not cover. I lost over twenty pounds. . . . I no longer have enough funds to get the food supplements I need to stay healthy. . . .

My financial worker has told me today that I will get some fuel next week. But it will last only for five or six weeks. This is the second week in February. This coming delivery will last only till the end of March. I MUST continue to heat my home until the first or second week in June.

Where do I go? Who do I turn to when my government turns their

**Labour Day Saturday Is HOBO DAY at Boy River!**

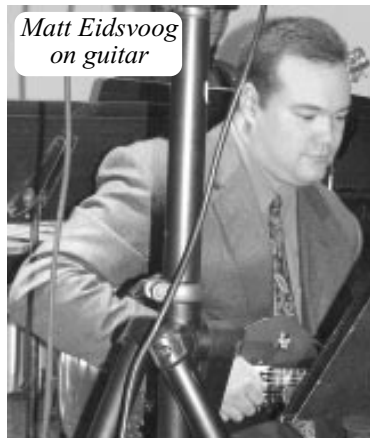

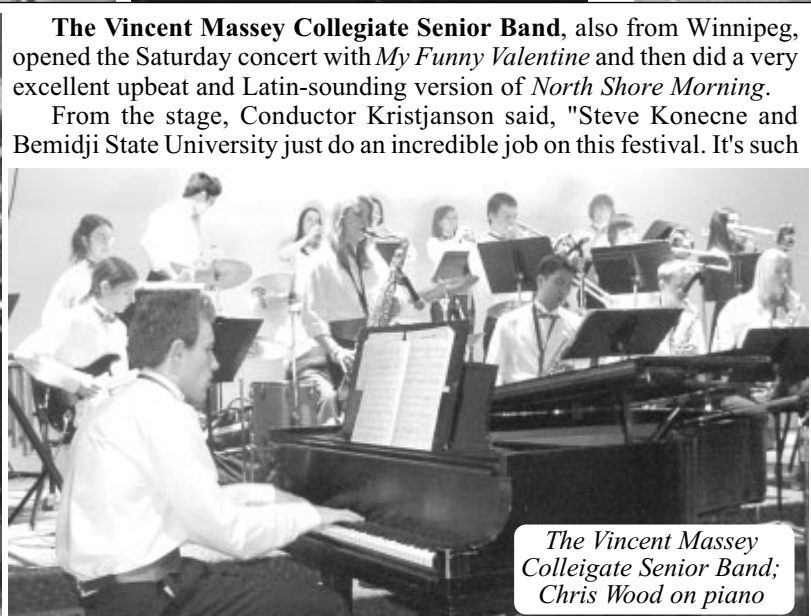

notifying her that she would be entitled to benefits. But Response Delivery Inc., only allowed her unpaid leave while she was recovering from her husband's death. After about two weeks of grieving, she was forced, financially, to return to work.

The day she returned to work, Heather was given, by Response, a paper to sign entitled, "Authorization Form For Consumer Reports". The paper, essentially a broad release form, authorized Response to procure from "any party or agency contacted by this employer" including financial institutions, various personal information, including credit and medical information and worker's comp claims. Heather was told that all employees, now, had to sign the form or be terminated. Heather found the form to be an invasion of her privacy, so, per her attorney's advice, she amended it, striking many items, so to include only such items as were related to her job, namely driving and criminal records, if any; and she otherwise completed the form and turned it in. "I dropped it off at the job . . . when I got back, . . . I was terminated."

After conferring with her attorney, Heather believes that she was given the release in an attempt by Response to develop evidence to use against her, should she bring a court action against Response for the death of her husband. She said that two other employees balked at the release; one was given another opportunity to sign it, and did so; the other refused to sign and was terminated, but was rehired two weeks later. Only Heather was summarily terminated without recourse.

**Unemployment.** Heather made an unemployment compensation claim, which, she said, Response contested, maintaining that the termination was due to "employee misconduct". Per Heather, however, at her administrative hearing, almost three months later - in late October 2005, Response's claim of employee misconduct was found to be without merit, and

attorneys at law. "They were

really trying to prove that my 35 year old husband had had a heart attack and died of natural causes," Heather said. Then they

got the autopsy report, and Heather Gilmer hired an attorney, Dean Margoles, Esq., of St. Louis Park, Minn.

Eventually, Response admitted liability for worker's comp payments. But Johnson & Condon, Esqs., in a letter dated November 2nd, 2005, misfigured the benefits at only \$35.41 per week. The computation contained an offset based upon an assumption that Social Security Survivor's Benefits would be paid; trouble is that neither Mrs. Gilmer, nor her two children by Eric, are eligible for same.

broken a law by making him drive a second shift. . . . there's no governing standards whatsoever by the State or the federal government for any courier who drives something less than 10,000 pounds. . . . The courier company is getting away with murder. . . ." Mrs. Gilmer has contacted various representatives, including Minn. Senator Carrie Ruud, to have these lighter vehicles made subject to the same driver's standards as other over-the-road trucks; as of this printing, however, she has not been aware of any legislative action having been taken, and calls to Ruud for comment have not been returned.

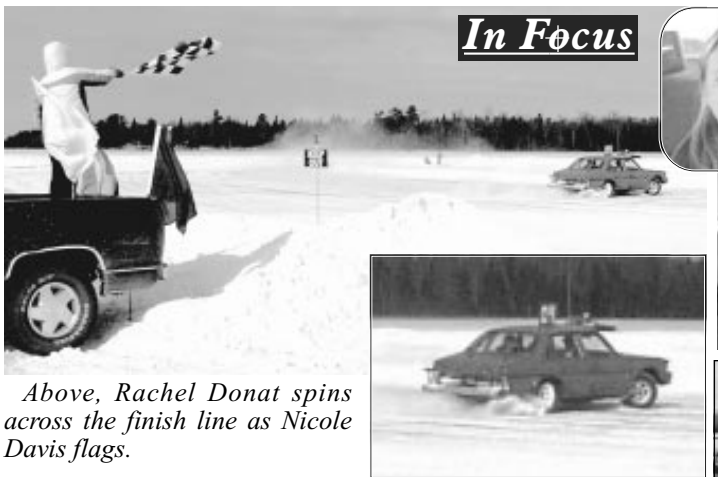
**Wrongful death provision; Minnesota attorneys.** An employer who is recklessly neglectful of employees' safety may become liable for his wrongful death, but Mrs. Gilmer said, "No lawyer whatsoever, that I have talked to, will go for that. . . . Every one of them says that I do not have enough of a claim to sue for wrongful death; but my husband would be alive if it had not been for their [Response's] gross neglect. . . . I know that I am not the only widow for a courier company that has suffered from this very same [type of] loss. . . . One of the other drivers said that . . . [there was] a DHL driver, just a couple years previous, that was killed on the job as well. . . . I can sue for wrongful death, but no lawyer in the country wants to take it."

Mrs. Gilmer's attorney, Dean Margoles, Esq., in a telephone interview, explained the problem under current law, "[There's an] *exclusive remedy* provision or doctrine of the work comp law. . . . [It] basically says that if someone's injured on the job, you cannot sue the employer for negligence; work comp is your

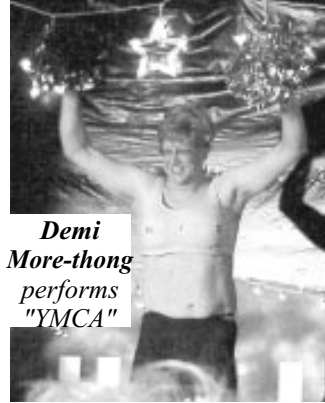

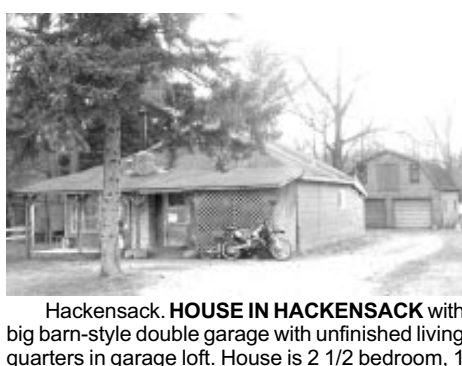

continued, "They [Response] have sent a lot of the drivers out in very unsafe vehicles." She recounted how both she and her husband had to finish routes in Response vans with "no brakes"; that the brakes failed in the middle of a route, and rather than pick up the driver, or send another vehicle, Response instructed the driver to finish the route in the vehicle with failing or failed brakes. How did they stop? "Well, after so many years of being a courier, you learn how to do certain tricks, like slow down a long time before you have to stop [and] pray that you don't have a deer run in front of you," she said. She said that both she and her husband, on separate occasions, have had to stop and buy brake fluid, repeatedly, and continuously install it, while on a route, "because it was leaking" from the Response vehicle. She recalled a van to which her husband had to add 6 containers of brake fluid "just to get home."

"We've had vehicles [which had been making noise for some time] that the total back end of the vehicle has fallen out in the middle of the road. There's no protection, by the government standards, for anything under 10,000 lbs. . . . And OSHA

doesn't see it as necessary to protect us. - The federal . . . [and State] government does not see that there's a need for protection," Mrs. Gilmer said. She added that when another Response driver refused to take an unsafe vehicle out, he was fired.

The condition of the Response Delivery, Inc. vehicles, and the state of their drivers, of course, poses not just a serious threat to their drivers, but to the driving public on the road, as well.

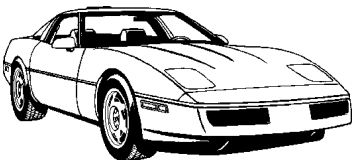
